REPORT OF THE SECRETARY-TREASURER, 1987

The Academy, as of December 21, 1987, enjoyed the support of 54 paid-up members for 1987, reflecting a gain of new members but also the failure of 32 members who had paid for 1986 to pay their subscription for 1987. The recent increase in dues, coupled with the absence of election expenses in 1987, resulted in an operating surplus of \$209.40. Income for 1987 totaled \$343.37 with expenditures being \$133.97. On December 21, 1987, the balance in the Academy's checking account was \$1,650.06.

WASHINGTON MEETING

"Charity and Piety in Medieval Society" was the subject of a panel jointly sponsored by the Academy and the American Historical Association in Washington, D.C. on December 28, 1987. President James F. Powers chaired the session; commentary was provided by Robert I. Burns, S.J. Summaries of the two papers follow.

Jill R. Webster, St. Michael's College, University of Toronto, "Manifestations of Popular Piety in Medieval Aragon."

Medieval piety extended to areas such as almsgiving, apparitions, miracles, and the care of the sick and even to art and architecture. In the thirteenth and early fourteenth centuries, the Mendicant Orders were the prime inspiration for works of charity and the erection of splendid buildings, adorned as they were by paintings, carvings and other works of art. Similarly, they aroused pious sentiment among the populace and this was frequently expressed in ways which could be regarded as quasiheretical.

The miraculous events in Montpellier -- the appearance of a bright light which came to rest over the crucifix in the Chapel of the Holy Cross of the Carmelite house -- required a bishop's court to verify the witnesses' accounts, given some seventy years later. The fact that they were only brought to light at the end of the fourteenth century suggests that those who witnessed the "miracle" were frightened of the Inquisition, which had been especially active in Languedoc in the 1320s, when the miracle had

occurred. Other unexplained phenomena occur in Narbonne and Lérida, examples only of the prevalence of a form of popular piety which saw the hand of the Lord or that of the Devil in the appearance of unusual events. Indeed the latter caused the Trinitarians some consternation when he appeared to them on a stormy night and succeeded in removing the roofs from their church and cloisters, seen as a possible retribution for their sins.

Illumination of Bibles, retables, paintings, the dedication of chapels -- all these showed the way in which medieval man expressed his popular devotion. Hospitals cared for the sick; hospices sheltered the homeless and indigent; and those with contagious diseases were isolated outside the cities. Language and literature, through the exempla and sermon structure of many works reflected the way in which medieval piety permeated every aspect of life. All of these expressions of devotion to the Christian faith are important for the understanding of the Middle Ages and especially the thirteenth and fourteenth centuries.

James W. Brodman, University of Central Arkansas, "The Origins of Hospitallerism in Medieval Catalunya"

This paper addresses the evolution of hospitallerism and organized works of charity in Catalunya between the eleventh and fourteenth centuries. This activity begins with the foundation of a number of hospitals of episcopal and capitular patronage in the eleventh and early twelfth century. Located next to the cathedral, these afforded care, food and shelter to the needy. Specialized hospitals that provided assistance to lepers and other sufferers of skin disease, the old and infirm, foundlings and captives appeared in the later twelfth and in the thirteen centuries as the work of individual clerics and laymen and an assortment of religious orders and confraternities. At the end of the thirteenth century, new charitable foundations took on a more municipal character as town governments assumed control of some privately endowed hospitals and as parishioners established neighborhood alms funds to care for the local needy. The pattern of charitable development thus noted in Catalunya is similar to that detected by others north of the Pyrenees, but nonetheless, because of the essentially local character of this caritative patronage, also demonstrates a distinctively Catalan dimension.

KALAMAZOO, 1988

Four panels of interest to Academy members are scheduled for the Twentieth-Third International Congress of Medieval Studies, May 5-8, 1988, at Western Michigan University. The first, sponsored by the Academy and organized by Donald Kagay, is entitled: "Foral and Customary Legal Traditions of the Medieval Iberian States." Papers include:

Professor Joseph O'Callaghan of Fordham University will comment.

Two sessions are sponsored by the Society for Spanish and Portuguese Studies, each organized by Larry Simon and Donna M. Rogers and entitled "Women in the Medieval Crown of Aragon". Presentations will be made by Academy members Clifford Backman, Mark D. Meyerson and Larry J. Simon.

"Silos in 1088" is the title of a program sponsored by the International Center of Medieval Art under the direction of Constancio del Alamo and Elizabeth del Alamo. This will include an exhibit of photographs of the Silos church, cloister and manuscripts, a concert of liturgical music from medieval Spain performed by the Schola Antiqua Exiliensis (directed by Ismael Fernández de la Cuesta), and three sessions. These are entitled: "The Historical Moment," "Manuscripts and Music," and "The Church and Cloister." Papers will be read by Academy members Bernard F. Reilly and Elizabeth del Alamo.

OTHER CONFERENCES

Two panel have been tentatively scheduled for the Academy's winter meeting in Cincinnati at the convention of the American Historical Association. Presentations are planned by James Todesca, Theresa Vann, Clifford Backman, Thomas Burman, Christopher Davis, and Larry Simon.

Espacios y tiempos en el monacato is the theme of a conference to be held December 5-10, 1988 at the Church of San Isidoro of León. Papers up to 15 pages are welcomed; titles should be sent to Dr. Horacio de Santiago Otero, Departamento de Historia Medieval, calle de Duque de Medinaceli 6, 28014 Madrid. The registration fee is 3,000 pesetas.

The Second Pennsylvania Symposium on Medieval and Renaissance Studies will be held on October 28-29, 1988 at the University of Pittsburgh. Abstracts for papers (300-500 words) should be sent by May 15, 1988 to Dr. Barbara N.
