CHICAGO 1991 MEETING

The following papers were included in the Academy's program at this joint meeting with the American Historical Association.

Martin Elbl (Trent University), "Tracking Economic 'Long Waves' in Medieval Mediterranean Commerce"

At present we do not possess any coherent picture of general medium- to long-run fluctuations in late medieval Mediterranean trade. The precise chronology of developments in trade and manufacturing has always posed a problem in medieval economic history, given that long time series of prices are much more readily available than those of "real variables". The present study attempts to contruct an indicator of the relative intensity shipping movement for a specific sector of Western Mediterranean trade, assess its validity, test its representativeness by gauging it against independent traffic data from other maritime trade sectors, and outline options for the model's refinement. Combining archival and published data, the study creates a composite model of traffic fluctuations based on the number of ships leaving Majorca, Valencia, and Barcelona for the Maghrib. model is then tested to establish whether it will pick up with some accuracy fluctuations of shipping movement or of maritime commerce registered by unrelated series tracking a) the auction bids for the Venetian Levant galleys, b) Venetian galleys sailing in the Alexandria and Beirut convoys, c) Venetian "cotton" cogs sailing for Levant ports, d) Florentine galleys sailing to all destinations, e) Genoese ships bound for Maghribi ports, and f) Genosese coral boats calling on the Maghribi coral-fishing station at Marsacres.

On the whole, the concordance in the chronological patterning of more or less clearly defined peaks in traffic movement proved to be remarkably strong. Major peak concordances were detected in the 1360s, in 1390-1400, in the 1420s, the 1440s, and around 1460; minor peak matches were established for c. 1470, 1480 and for the mid-1490s. In general, the present set of series exhibited repeating movements of some 20 to 30 years in length, and minor ones of some 10 years. As far as "classic" long wave or

"Kondratieff cycles" are concerned, the composite indicator revealed a strong visual pattern of sharp peaks around 1350-60, 1400, 1460 and 1510, yielding fluctuations of 40-50, 60 and 50 years. But, as in other studies of this kind, spectral analysis of selected series was unable to corroborate the visual pattern, bringing out most clearly periodicities of only 20 to 28 years, 7 to 11 years, and 4 to 6 years.

The next step should be to see how the current model's patterns withstand a transition from using Maghrib trade voyages as a base to using the departures of Catalan ships for all destinations. Then, as many similar series as possible from other parts of the Mediterranean ought to be compiled to allow further testing of pattern robustness. If the patterns prove stable enough, we shall have to attempt determining the economic structures and processes behind them, but there certainly would seen to be hope for establishing a sound general benchmark for the movement of late medieval Mediterranean maritime trade. Situating exceptions in relation to such benchmarks and thus stimulating debate and explanation has invariably proved fruitful.

Olivia Remie Constable, "Push It or Perish: Legislation on Shipwreck and Jettison in Spain and the Medieval Mediterranean World"

The focus of this paper is on the Consulate of the Sea, a famous collection of Catalan maritime law, in which most of the provisions concerning jettison date to the 14th century, though some may originate as early as 1075. This compilation of law is considered within the wider context of Mediterranean sea law, cluding the Digest, the 7th-century Rhodian Sea Law, medieval vernacular and Latin texts from Amalfi, Pisa, Ancona, Bordeaux, Castile, Aragon and Valencia, and Islamic fatwas or legal opinions. The analysis of jettison law shows that the Consulate of the Sea was a self-conscious (and ultimately unsuccessful) attempt to lay out a coherent corpus of sea law. It drew upon a diverse maritime legal tradition which it sought to codify, reconcile, select, and reduce in the pursuit of a unified body of synthetic law. Its particular rulings on jettison, whether or not representative of actual practice, are in line with those found in other medieval Mediterranean texts. If some of its rulings seem impractical, it stemmed from the attempt to solve a virtually unsolvable legal problem.

Dear Members,

At the poorly-attended business meeting at the AHA in Chicago we discussed the following proposals which I hope to bring to the membership at Kalamazoo:

- 1. The revision of the Constitution -- there are a few changes which need to be made to bring it up to date. These are not substantial and I will distribute copies at Kalamazoo. If accepted, we can vote then or the matter can be decided at the AHA in Washington.
- 2. Proposal to raise fees from \$4.00 to \$5.00 -present graduate students can continue at the old rate. A rate
 of \$5.00 does not make much difference to members but would help
 meet the costs of the proposal under (3). You will notice that
 the new application form takes this for granted and puts \$5.00
 as the fee.
- 3. Proposal to institute a prize for the best published essay by a graduate student in the academic year preceding the AHA meeting. It was suggested that a token prize of \$100 be given and that the prize be called "Research Historians of Medieval Spain Prize for best graduate student article".
- 4. Institution of a special panel or round table for graduate students at the AHA and that this not necessarily be on a historical topic but oriented towards professional concerns (preparation for job interviews, articles, consultation in archives etc.)
 - 5. Administration of Burns Fund.
- 6. We need to do something to attract new historians as many of the graduate students in medieval Spanish history are not members. The suggestions above are part of an attempt to respond to this need but other suggestions would be welcomed at Kalamazoo or the AHA.

7. A meeting of AARHMS will take place immediately following the first panel in honour of Father Burns at Kalamazoo - that is Panel No.66 Studies in Honor of Robert I. Burns, S.J. I in Room 1010 Fetzer at 1.30 p.m. on Thursday, May 7, 1992. All members are urged to attend as there are several items of business and especially concerning the Burns Fund.

I have redone the brochure distributed some years ago and copies will be available at Kalamazoo or from me by mail. I have kept it simple but separated the Application Form so that as new Secretary-Treasurers are elected only that page need be redone.

BOOKS RECEIVED

Conquerors and Chroniclers of Early Medieval Spain, translated with notes and introduction by Kenneth Baxter Wolf, Liverpool University Press, 1990. ISBN 0 85323 047 1

This volume in the "Translated Texts for Historians Series" includes translations of four Latin chronicles. The Chronicle of John of Biclaro and the History of the Kings of the Goths of Isidore of Seville demonstrate how the Visigothic kings were legitimized as rulers of Christian Spain. The third is an anonymous continuation of John of Biclaro's Chronicle written in the mid-eighth century by a Christian living under Muslim rule; the fourth, attributed to Alfonso III, was intended to continue that of Isidore. In a series of essays, Wolf examines each of the texts for the information provided on the Islamic conquest of the peninsula and tries to understand the perspective each author has on the conquest. In addition, there is an index, map, and two bibliographies.
