DECEMBER, 1981 MEETING (LOS ANGELES)

No business was transacted at the winter meeting of the Academy; the principal activity was the session, entitled "Military and Religious Orders of the Iberian Peninsula" and organized by Professor Paul Freedman of Vanderbilt University. Summaries of the following papers have been submitted for inclusion in this edition of the Newsletter:

 "Christian Settlement in the Urban Reconquista Frontier," Jane C. Wilman (University of California, Los Angeles)

The settlement of the Reconquista frontier in the Mediterranean littoral was problematic for Jaume I, king of the confederated Crown of Aragon. Within the perspective of the attempt to colonize and control the newly conquered land of Valencia, it is instructive to examine the career of one settler as paradigmatic for the larger movement. Using forthcoming and unpublished documents from the royal chancery archives of the Archivo de la Corona de Aragon in Barcelona, the career of one settler has been traced from his earliest mention in the royal records (a land grant in Valencia's Repartimiento) to orders issued to his daughters' guardian following his death in 1271. We learn not only the public aspects of his life, such as property ownership and service in public office, but personal aspects as well: his marriage in early 1258, his four daughters (two of whom were illegitimate), and his circle of friends and fellow entrepreneurs. Through an in-depth examination of one settler's life, a tentative pattern of one class of colonist may be formed.

2. "Medieval Urban Topography: Case Studies of the Jewish Quarter of Thirteenth-Century Barcelona," Leila Berner (University of California, Los Angeles)

This paper is the result of a combination of archaeological and documentary evidence obtained during Ms. Berner's recent research stay in Barcelona. The documentary evidence, gleaned primarily from the royal registers of Jaume I, el Conqueridor (1213-1276) at the Archives of the Crown of Aragon, reveal much valuable information concerning Barcelona's Jewish community in its physical environment. Ms. Berner used this data to discuss Jews' interactions with their Christian neighbors, the establishment of public community structures (such as a synagogue, ritual bath, public oven, etc.) and the Jews' activities in the purchase and sale of real estate in Barcelona and its environs. The central focus of the paper is on a royal concession to a prominent Jew, Astrug Bensenyor,

to make repairs and changes in his home within Barcelona's Jewish quarter (the <u>calle iudaica</u>). In the process of investigating this grant, Ms. Berner attempted to solve some important topographical puzzles concerning the Jewish quarter. The results of her research revealed the exact location of Astrug Bonsenyor's home and the location of an important entrance gate into the Jewish quarter. Neither the house nor the entrance way has been hitherto pinpointed with any certainty. In addition to the archaeological and documentary discussion, the methodological point of Ms. Berner's paper was to illustrate how specific, small-scale studies (of individual houses, gates, streets, etc.) are essential to the social historian who must use the tools of many trades to establish a comprehensive picture of the social history of a particular city or ethnic group.
